

## Privacy policy

### Statement of Policy

This Privacy Policy applies between you, the User of this Website, and Yellow Zebras Consulting Ltd, the owner and provider of this Website. Yellow Zebras Consulting Ltd takes the privacy of your information very seriously. This Privacy Policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

### Definitions and Interpretation

A. In this Privacy Policy, the following definitions are used:

<b>Data</b>	collectively all information that you submit to Yellow Zebras Consulting Ltd via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;

<b>UK and EU Cookie Law</b>	the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011 & the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2018;
<b>User or you</b>	any third party that accesses the Website and is not either (i) employed by Yellow Zebras Consulting Ltd and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Yellow Zebras Consulting Ltd and accessing the Website in connection with the provision of such services; and
<b>Website</b>	the website that you are currently using, <a href="https://www.yellowzebras.com/">https://www.yellowzebras.com/</a> , and any sub-domains of this site unless expressly excluded by their own terms and conditions.

B. In this Privacy Policy, unless the context requires a different interpretation:

1. the singular includes the plural and vice versa;
2. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this Privacy Policy;
3. a reference to a person includes firms, companies, government entities, trusts and partnerships;
4. "including" is understood to mean "including without limitation";
5. reference to any statutory provision includes any modification or amendment of it;
6. the headings and sub-headings do not form part of this Privacy Policy.

### Scope of this Privacy Policy

1. This Privacy Policy applies only to the actions of Yellow Zebras Consulting Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
2. For purposes of the applicable Data Protection Laws, Yellow Zebras Consulting Ltd is the "data controller". This means that Yellow Zebras Consulting

Ltd determines the purposes for which, and the manner in which your Data is processed.

## **Data Collected**

We may collect the following Data, which includes personal Data, from you:

- a. name;
- b. contact Information such as email addresses and telephone numbers;

in each case, in accordance with this Privacy Policy.

## **How We Collect Data**

We collect Data in the following ways:

- a. data is given to us by you; and
- b. data is collected automatically.

## **Data That is Given to Us by You**

Yellow Zebras Consulting Ltd will collect your Data in a number of ways, for example:

We will use technical and organisational measures to safeguard your Data, for example:

- a. access to your account is controlled by a password and a user name that is unique to you.
- b. we store your Data on secure servers.

## Data Retention

## Your Rights
